As you may be aware we are no longer able to accept cheques. Please use internet or phone banking to deposit money into our account.



Daivid Mellish and Robert Morey represented Otago at the annual GSA Council held in Wellington recently where several minor changes were made to the constitution and all accounts for branches and head office were presented and passed.

There were two guest speakers:

Tracy Martin from the Aged Care Association spoke about residential care and some of the problems the sector is facing. Did you know that 60% of the providers are small charities and 40% large companies?

The other speaker was Ireen Muir from the Government Superannuation Fund Authority who gave us some "in house" details of their latest survey of members.

They also attended workshops on the Strategic plan 2025-2027 and recruitment and retention.

Waikato-King Country Branch presented figures outlining the future of the GSA and Branches. Projected financial reserves would run out by 2044 and there would only be 1200 members left
