GSA NATIONAL COUNCIL (AGM): CHAIRPERSON'S REPORT JOHN CAMERON

Greetings,

At our last AGM, I was elected Branch Chair for the next three years.

I joined the Government Superannuation Scheme just before it closed to new members in 1992 and I am eternally grateful that I did. I worked in various positions at the University of Waikato from 1988 until 2016, under four Vice Chancellors. For the last 16 years of my service I was Director of Facilities Management, responsible for building and maintaining all the facilities as well as Security, cleaning, Emergency Preparedness, and, of course, Parking. Enough about me.

Over the weekend of 6/7 September, I attended my first GSA Council Annual meeting, the GSA's national AGM. The primary purpose of the Association is to protect our annuities. It also represents members' interests when general and individual issues arise. To this end, the GSA maintains a very good relationship with the Government Superannuation Fund Authority (GSFA). The principal role of the Council is to ensure that members are getting good value for their subscriptions. Just over 50 people attended Council: the National Board, Branch delegates, some life members, and staff.

Of the 44,000 people in the Scheme, only about 2,500 are yet to retire. Unfortunately, over half of all annuitants are not members of the GSA. That risks undermining the Association's effectiveness, especially if the Scheme were to be under threat from a less than sympathetic Government. PLEASE, if you know anyone who is receiving an annuity and doesn't belong to the GSA suggest to them that it is in the interest of both them and their partners to belong. Make sure you provide them with our Secretary, John Evered's contact details (See Page 4).

There are five main matter on which I now want to report.

- 1. The GSA is a "sunset" organisation. Its members are getting older. But it will be well past 2050 before all those members and their spouses pass away. Over a long period, our Branch has taken the lead in preparing detailed modelling that charts the steady drop in the Association's financial membership. That work is the basis on which the GSA determines the income it will need, over the next two to three decades, in order to ensure it remains viable. Based on that modelling, Council approved a modest increase (\$0.30 per four weekly payday) in the annual subscription.
- 2. Council elected a new Board. Sandie Gusscott (Auckland) is the new President; Alan Peck (Wellington) is the new Vice President. Council re-elected sitting Board members John Beckham (Otago), Anne Gover (Southland), and Roger Openshaw (Manawatu). It also elected two new Board members, John Laurenson (Horowhenua/Kapiti), and Darryl Bellamy (Bay of Plenty).
- 3. We had a very interesting, topical address from the Hon Tracey Martin, a former NZ First MP and Minister for Seniors. Now CEO of the Aged Care Association of New Zealand, she made a number of important observation:
- NZ has an aging population, but successive governments have not planned adequately for its needs;
- About 25% to 28% of that population will eventually need some form of Residential Care;
- Over the next five years, there will be a shortfall of 12,000 Residential Care beds;
- If nothing is done to provide those beds, by 2043 nine out of every ten hospital beds will be occupied by people over the age of 65; and
- It is of very serious concern that almost all Psycho-geriatric care is provided by the not-for-profit sector, not the large, for-profit Retirement Village owners. The not-for-profit sector's capacity is well short of what is required.
- 4. We were addressed by Ireen Muir who is employed by the GSFA as the General Manager for all the Government Superannuation and National Provident Fund schemes. The Fund pays annuitants over \$1 Billion a year. The Government pays approximately 1/3rd. The GSFA surveys members every three years. It has a 80% satisfaction rating. Appeals also measure satisfaction. There has been only one in the last two years. The GSA has a nominee on the Appeals Board.

5. Lake Taupo Branch merger with Waikato-King Country Branch.

This is highly relevant to our Branch. Council resolved that from 1 April 2026, the Lake Taupo Branch, with its funds, will merge with the Waikato-King Country Branch. The move was initiated by Lake Taupo Branch members at their last AGM. This merger will bring an additional 160 members into our Branch. At Council, we had a very productive discussion with the Lake Taupo Branch's delegates and have already taken initiatives to welcome those new members into our Branch. In October we will host local events in Taupo and Turangi (See Page 1 above)

DIRECTIONS TO HAMILTON WORKINGMEN'S CLUB

The Hamilton Workingmen's Club is located at 45 Commerce St, Frankton.

It is best to enter Commerce Street from Norton Road. The Workingmen's Club is approximately half way down the first block, on the left-hand side. There is plenty of parking.

From the North: Take Te Rapa Road into Ulster St. Turn right into Mill St. Turn left into Norton Rd. Turn Right into Commerce St.

From the West: Take Massey St. to Norton Rd. Turn right into Norton Rd. Turn right into Commerce St

From the South: Drive to Tristram Street. Turn left into Tristram St (at Pak'n'Sav). Continue on Tristram St to Ward St. Turn left into Ward Street which becomes Seddon Road. Continue along Seddon Road to Norton Road. Turn left into Commerce St.

From the North-East, cross the Waikato River at a preferred bridge. Drive West down Mill Street to Norton Road. Turn left into Norton Road. Turn right into Commerce Street.
