The main topics for discussion were the 2025-2027 strategic plan, amalgamation of Branches, subscription levels, transfer of the management of overseas members from Wellington branch to the National office.

The GSA holds the view that it is the responsibility of the Association's current leadership to plan strategically to ensure we remain viable for the benefit of annuitants. To achieve this goal there are three priorities:

To prudently manage the Association's finances;

To maintain an effective Branch structure – active local branches ensure better contact with members and protect their interests;

to keep building membership, to avoid using the Associations' reserve funds.

This final goal can be progressed through the recruitment leaflet sent via GSF/Datacom and National Office to non-GSA and through Branches encouraging surviving spouses to become members.

Member's GSF Annuities are a contract between the employee and the Crown, the employer, to provide an annuity, protected by the 1956 Government Superannuation Act. The Govt Super. Assn role is to protect the annuities and promote to successive Governments maintenance of the "deferred employer contribution from the Crown".
