#### **NEW EXECUTIVE OFFICER: JENNY BARCLAY**

As noted in his Annual Report (Page 3), our Chairperson, John Moodie, recently took the opportunity to meet the GSA's new Executive Officer, Jenny Barclay. The Association has been very fortunate indeed to attract a top quality successor to Alan Peck. Jenny is a GSF Annuitant and a GSA member. She brings to the position extensive experience in the public sector including senior leadership positions in tertiary education, both in New Zealand and overseas. Jenny also held a senior position at Te Papa Tongarewa. We look forward to Jenny attending a branch function some time in the future.

#### **NEW GOVERNMENT: NEW OPPORTUNITIES**

The election of a new Government offers an opportunity for the GSA to resolve several outstanding issues. These include the unfair way in which the Cost of Living Allowance is calculated for our oldest members and our ongoing concerns over the detail of the pre-taxation of our annuities. Members will recall that the two previous Ministers responsible for the GSF, Hon Bill English and Hon Steven Joyce, were not receptive to our concerns. Our National Board will be meeting the new Minister, Hon Grant Robertson, in the near future. The Board also expects to have a positive discussion with the GSF Board once new members have been appointed.

## PROTECTING OUR LONG TERM INTERESTS

Although the GSA has an ageing membership, it is vital that it remains a viable, effective organisation for as long as possible. In late 2016, the Waikato-King Country Branch initiated a national discussion on the Association's future. Our National Board responded positively and much progress has resulted. One outcome was the recent, modest increase in our annual subscription. Another, is the appointment of Board Member, Tony Hamilton--who is well known to our Branch—to chair a important sub-committee. Its task is to develop a long-term, strategic approach to the branch restructuring that will be necessary as our membership ages and declines. The Waikato-King Country Branch welcomes both the establishment of this sub-committee and Tony's appointment as Chair. Your committee will be making input as appropriate.

## Annual Report for the year ending 31 March 2018

This, my first year in the chair of the Waikato King Country branch, has gone very quickly and smoothly due to the efficiency of our secretary John Evered and the support I have had from the committee.

The GSA has 19 branches. A branch's role is to:

- arrange social opportunities for members to meet and engage with each other;
- provide advice and assistance to members as required;
- keep members informed about and seek feedback on current issues; and
- liaise with the GSA National Board on issues of concern to members.

At the AGM in June a strong committee was re-elected and later Alan MacDonald, recently transferred from the Manawatu, was co-opted.

A well supported lunch in Cambridge was chaired by Michael Law and this event has now firmly established itself in our calendar. The Hamilton morning tea was most informative, with guest speakers from Civil Defence and Neighbourhood Support.

The Christmas function at the end of November was a departure from previous years in that it was held at Riverlea Arts Centre. Our Board liaison representative, Tony Hamilton, who has supported our branch so ably, spoke about the future direction and the issues challenging the GSA.

Regional lunches held in Matamata and Taumaranui were attended by committee members from Hamilton. Your committee members appreciate the opportunity to meet with members and to hear of any concerns.

John Evered, Joan Currie and I attended the Council meeting in Wellington in September. The main issues discussed centred around the long term Strategic Plan and in particular measures that will ensure the viability of the organisation for the next twenty plus years.

Our branch supported the move to increase the subscription. We argued that building reserves now, while the membership numbers are high, means that the burden is spread more widely and the organisation is better equipped to fight any legal battles that might occur.

We also supported the move to consolidate the organisation's funds centrally so as to better the returns. The exact details of this have yet to be finalised but branches would still have funds to cover the things they do at present.

Probably the most enjoyable thing for me was to receive on behalf of Rob Grant, a long time member and committee member of this Branch, a Certificate of Life Membership. Rob was nominated by this branch but now lives in Rotorua. At the kind invitation of the Rotorua Branch, a group of us went to a Rotorua branch meeting where I was able to present the Certificate to Rob.

In March I travelled to Wellington and met with our new Executive Officer, Jenny Barclay. I was very impressed with her knowledge and her grasp of the GSA and its problems. I am sure the GSA is in good hands.

I would like to thank all our committee members for their work and support throughout the year in particular I would like to thank John Evered, our secretary, who produces the best minutes I have come across.


