**2020 ANNUAL COUNCIL MEETING 5/6<sup>TH</sup> SEPTEMBER AT WEST PLAZA HOTEL, WELLINGTON.**

**Chairman John Russell and Committee member Alec Waugh were the chosen representatives at this year's Council meeting, held at West Plaza Hotel.**

**Due to covid 19 issues, a number of apologies were received with Otago and Horowhenua Branches not present, but the remaining 17 branches were in attendance.**

**The highlight of the conference was the launch of the Centennial History 1920-2020 SAFEGUARDING SUPER; THE GOVERNMENT SUPERANNUITANTS ASSOCIATION. Originally this launch was to be hosted at Parliament by the Finance Minister, but covid 19's restriction meant this did not occur, and the launch took place at the Council dinner on the Saturday night.. Author Roger Openshaw gave an engaging 15 minute address and to applause the book was made available. Members should note that Roger is our guest speaker at our Christmas function in December and copies of the publication will be available for purchase at a cost of \$40.00.**

**Tony Hamilton (Northland) was re-appointed President with Alan Straker (Marlborough) Vice President. The board for the 2020/21 year is Rob Brangwin and Marjorie Thomas (Hawkes Bay) Dallas Elvy, Alan Peck and Mike Smith (Wellington)**

**Life member appointment was Maurice Sinclair (Canterbury)**

**Business issues centered around subscriptions, with the Council voting in favour of a subscription increase to \$2.50 per annuity pay day (\$32.50) annually. The rationale for the increase centered around current and future financial viability, including sufficient funds to safeguard our annuities from any possible political attempt in the future to amend annuity provisions. This possibility is unlikely but a prudent organization always prepares for all possible contingencies. Nelsons position was supportive in principal to the motion, but we felt it should have been increased further to avoid having to review this issue each year.**

**The meeting spent considerable time addressing policy re future amalgamation issues or similar as branches are challenged by either**

**dwindling committee numbers or a lack of nominations to take leadership positions within each branch. Future proofing and the many elements to these issues received robust and discussion and will remain as likely future council agenda items.**

**The Cola issue affecting pre1985 annuitants is still an outstanding policy issue, the Minister of Finance Grant Robinson indicating he will address the issue, if re-elected at the 17<sup>th</sup> October 2020 election?**

**An attempt by Canterbury district to re-open the Annuity Reduction factor issue which was dropped from the policy agenda in 2017 was unsuccessful, Nelson did not support Canterbury's motion.**

**Discussion also took place on Double Taxation issues which only affects GSA members who reside internationally. The GSA keeps a watching brief on these matters. Nelson made the suggestion a briefing paper on this topic, including the numbers affected and their locations might be a useful educational and reference tool. There are 40 tax treaties in existence and a further 12 under negotiation.**

**Recruitment of new members is always a council issue, including retention of existing members and it remains very important for spouses of members to be identified and enrolled where possible. Local knowledge and contact of GSA annuitants are still the best method of maintaining our numbers and protecting Annuities.**
