Council Report-2020

The annual National Council meeting was held in Wellington on 5-6 September. This year celebrated 100 years of activity by the Government Superannuitants Association. To mark this milestone, a centenary publication was commissioned. The plan was to launch this publication at Parliament, hosted by the Minister of Finance Grant Robertson. Covid-19 restrictions meant the event was cancelled. The book, 'Safeguarding Super' was therefore launched at the Council dinner the following evening, preceded by a witty address from the author Emeritus Professor Roger Openshaw.

Council opened with the Presidents Report followed by a Financial Report which recorded a surplus, largely due to good management by the GSA Board. A zero budget is forecast for the current year. As costs rise and membership decreases any surplus will gradually be eroded. A healthy organisation going into the future is paramount to safeguard Annuities. The Council, accepting this premise, voted to ensure this situation continued. Subscriptions will now rise to \$2.50 per 28 day pay period.

During the Strategic Plan Reporting, discussion was goal driven. Communication, advocacy and organization were discussed first and centered on how best to achieve a healthy responsive organization into the future. First steps were taken to address declining membership and difficulty in attracting office holders by approving an Amalgamation Policy. The remaining two goals were support of members and recruitment.

Stated policy objectives continue to be:

- Fairness and equity in taxation
- Universal and timely receipt of 100% cost of living adjustment (COLA)
- Fairness in remuneration for members still employed. We are fortunate that Alan Peck (our past CEO), who is now on the Board, is also now a member of the GSFA Appeals Board.

Board elections were not required this year. Current office holders were re-elected unopposed. We congratulate Tony Hamilton for being elected National President for a further 12 months.

Two new life members were announced. These were Michael Law from the Waikato/King Country Branch, and Maurice Sinclair from Canterbury/Westland. The guest speaker this year was Simon Tyler, Chief Executive of the Government Superannuation Fund Authority.

The GSFA also has a new Chairperson, Ann Blackburn.

The GSFA is responsible to the Minister of Finance and its goals are to use best practice to

- Maximize returns with minimal risk
- Meet the expectations of stakeholders

They are subject to a statutory 5 year review, next due in June 2021. In the financial year to June 2019/2020, \$901m was paid out to GSF annuitants.

Simon pointed out that their performance does not affect our annuity as the payment is underwritten by the Government. Key GSFA investments are in equities, with their success measured against a Reference Portfolio. They are expected to outperform Government bonds. They follow an ethical investment policy dictated by Government policy on such issues as tobacco based industries, climate change and reduction in carbon emissions. Simon summarised the challenges ahead for the GSFA including

- Continuing services in a Covid-19 environment
- Easing of monetary conditions globally
- Recent cyber-attacks on the share market
- The 2021 Statutory Review

The second day of the Council meeting concluded with a strategy session where Branches were able to give feedback to the Board on their vision for the future and the way forward.

The Annuity pathway: where the GSA has fitted in for 100 years

The Government Legislates, sets rules and delegates to GSFA.

GSFA (Government Superannuitants fund Authority) administer the funds that are paid out to Annuitants. They publish a report on all aspects of their operations every year. Including details of how much money they have, how they invest it, how many annuitants there are and the changes to these numbers. All information relating to their operations is on their website. <u>https://www.gsfa.govt.nz</u>

The GSFA delegates the business of paying the Annuities to Datacom.

Datacom send out a letter each March to inform Annuitants of the movement in the Consumer Price Index and how it relates to each annuitant's allowance.

GSA (Government Superannuitants Association) provides a collective voice to protect the superannuation rights of government employees who have contributed to one of the Government Superannuation Fund (GSF) schemes or the National Provident Fund (NFP).

As such the GSA safeguards the current provisions of the schemes and seeks to improve them by having deficiencies and anomalies removed. Further information relating to their operations is available on their website. www.gsa.org.nz


