MESSAGE FROM THE GSA BOARD,

Dear South Canterbury Branch Members.

It has been an interesting year, and that's an understatement. We hope that everyone has managed to stay safe while we navigate our way through these tricky times.

It has been a particularly interesting year for your branch. We say this because your branch needs you now more than ever.

As most of you will be aware, the branch was very effectively run by Alan Ferriss and his dedicated committee for many years. When Alan died in 2017 the reins were taken over by his widow, Alison. Alison and her small band of long-serving volunteers have done a terrific job holding the branch together, but now they need help.

Early this year it became apparent that the branch was in trouble. Alison could only count on the support of three committee members, some of whom had expressed a desire to be less involved after many years of commitment. The Constitution stipulates that a committee must have a minimum of five members, so we should note that the branch committee was, in fact, not viable. This situation has caused the Board some concern.

The aim of the Board is to maintain branches for as long as possible, but we have recognised that should a branch be unable to elect a viable committee the only alternative would be to consider amalgamating the branch with another. Local representation is important, but as membership ages and numbers drop some branches will cease to be viable. Amalgamation becomes the only option. Has South Canterbury reached that stage?

The Board was planning to use the AGM in May to push for some new faces to serve on the committee. As you know, the pandemic lockdown forced the postponement of the AGM and the Board decided to take no further action until an AGM could be held later this year.


There will be a short AGM on 26 November.


