Hawke's Bay Annual Report

Membership. As at 31 March 2020 we had 873 members, a drop of 5% from the same time last year. The reduction is almost entirely due to members or their

spouses passing away. We extend our sympathies to any of you who have lost a loved one.

Chairman's report. This is the GSA's 100th year and there will be details later in the year on recognition of that. The GSA History will be published and available later in the year. With membership declining the publication of the history will provide an essential record of "institutional" knowledge which is lost inevitably as membership declines by the attrition of age.

The Parliamentary Petition to secure 100% cost of living adjustments for pre 1985 retirees awaits decision after a positive Select Committee recommendation.

Your committee is thanked for its work on your behalf. Your committee is doubly fortunate in having two members Marjorie Thomas and Rob Brangwin who are also members of the GSA's Board.

Our Secretary Deb Renton-Green will not be seeking reappointment and she is thanked for her efficiency and member-focussed service over 4 years.

At our last Committee meeting, Ray Green advised he will not be available for renomination to the Committee. This was accepted with sadness but with understanding of Ray's medical situation and appreciation of the wonderful service he has given the Superannuitants' Association. Ray has served in various roles on the Committee for 20 years – initially with the Railways Superannuitants' Association Committee and then, after amalgamation, on the GSA Committee.

As members of this branch your support is essential for the existence and success of the Branch. You are thanked for providing that support by virtue of your membership and attendance at branch events.

Nevertheless, there are some clouds on the horizon. Income was down 6%. While the number of people attending our Christmas function has remained strong, fewer have attended the AGM, bringing function income down. Subscription income has also reduced as membership numbers have reduced.

The main increase in expenditure was in Communications. This is because the Branch (instead of National Office) now funds the printing of this newsletter – reflecting the need for National Office to trim its costs.
