# Chairman's Report, November. 2025

In my report for the April Newsletter, I wrote about expected employment cuts in the Public Service. Many have now happened, with more job losses still happening. Government Engagement of "spin doctors" will mean that we will hear only a little about the effects of these cuts and we have already heard reports from some Ministries about employees being forbidden to talk about them. We will all have our own stories. Two of my family are Public Servants and both have been very lucky in retaining their jobs. There were, however effects which weren't obvious before the process started. The two places that I know about do not have clear "front" and "back" office roles. Managers were required to make rapid decisions. The retained staff were not all the best staff but in some cases were those who were good at self-promotion. Office dynamics became scrambled as some managerial roles were re-assigned and were not the result of careful selection as would have occurred in a stable workplace. Government had already determined that unfilled vacancies at the time of down-sizing would not be filled. This was a further potential money-saving action because There would be no redundancy costs for those positions. The effect though, was that those vacancies, which were a natural transitional state in every workplace, were jobs now lost which could not be fitted into a pattern that a CEO might be pursuing when deciding

priorities for retention. In neither workplace I know about has there been any recognizable removal of "waste". Money saved? Definitely. Other good reason? Definitely not.

Public Service cuts might not be all bad. A small rural hospitality business owner near Christchurch wanted to sell the business earlier this year. No satisfactory bids. When asked later in the year, the owner said they are now very likely to get a sale because they have heard of ex Public Servants moving out of Wellington with their savings.

Annuitants may have noticed a small reduction in their annuity payments since April, the result of a subscription increase of .50 cents per payday, or \$6.50 over o whole year. I use the word "small" for the reduction because it is interesting to compare this with what annuitants are actually receiving. Of surviving spouses, our lowest income group who are receiving up to 50% of the original annuity, 99.7% are receiving more than \$7,500 a year. Of female annuitants 99.9% are receiving more than \$17,500 and of male annuitants 99.9% re receiving more than \$20,000. As the justification for a subscription increase was being developed prior to 2023 Council, the potential decline in annuitant numbers was projected into future years. When the actual percentage decline for the year ending March, 2024 became available for the Canterbury/Westland Branch, it was 6.4% compared with the previously projected number of 6.7% nationally. That close match in numbers gives confidence that the projection procedure is reliable. I wrote more detail about subscriptions in the Newsletter of last November, 2023, which is available on the Canterbury/Westland Branch, part of the GSA website, (although there it is called "October, 2023").

Council 2024 was held on the weekend of September 7-8. Our delegates were Maurice Sinclair and Tony Gooding, while two others from our Branch attended as Life Members: Gavin Stuart and Bernie Rose. For Tony it was a bit of a whirlwind with it being his first Council meeting, at which he was also elected to the Board. For many years it had been a concern that there were no South Island members on the Board, but Tony's election now makes it four from the mainland with President Alan Straker from Marlborough, John Beckham and Anne Gover from Southland and Tony Gooding from Canterbury/Westland. I am not providing a summary of the Council meeting, assuming that the business will be covered in the National Newsletter – Annuity News. As with last year's Council the meeting was short, with the formal parts finished by mid-afternoon Saturday. Two Board members had organised workshops for Sunday morning. Council is an extremely important part of the GSA process, but it is also a costly exercise. Despite our electronic world there is still a lot of support for face-to-face meeting and I am one of those advocates. There is certainly room for innovative thinking regarding the future organisation of our Council meetings.


