Report from the Chair, October 2024.

I trust that you are all coping with the cold wet weather we have been experiencing in the Manawatu during September, our first month of Spring. We can at least look forward to the Manawatu Branch Christmas Function in late November. I hope to see many of you there to enjoy the beginning of the festive season.

Secretary-Treasurer, Graham Poucher, and I braved the conditions to attend the Secretary-Treasurers meeting held in Wellington on Friday 6 September. This event was immediately followed by GSA's annual Council function which took place on Saturday 7 September and Sunday 8 September, both events being held at the West Plaza Hotel function rooms on Wakefield Street.

Regarding the Secretary-Treasurer's event, and speaking as someone who finds daunting any computer programmes purporting to make financial matters easier, I have to admit being impressed by the 'hands-on' presentations of the invited speakers. Each took us, step by step, through the complexities of MYOB, GSA's preferred method for recording Branch financial records. Nevertheless, by the end of Friday's sessions I found myself more than ever appreciative of Graham's work as Secretary-Treasurer on our behalf.

As you may know, Council is the supreme decision-making body of GSA. This means that any decisions made at Board level, together with remits brought forward by the various Branches are debated at Council and, if necessary, voted upon. Our guest speaker for Council 2024 was Ireen Muir of Annuitas. Ireen oversees annuity payments on behalf of both the Government Superannuation Fund and the National Provident Fund. I was most impressed by her presentation, particularly the manner she and her team deal daily with what are often highly complex issues regarding the payment of annuities.

Both the new GSA Strategic Plan and the modified Constitution were passed at Council with only minor changes being required. This will mean that we can hopefully jump the queue of over 20,000 societies wishing to have their organisations registered as Incorporated Societies.

At Council I was re-elected to the GSA Board for 2024-25. One of the major items for our next Board meeting in October will be GSA's Financial Reserves Policy. Passed at the 2023 Council, this policy

requires Branches to hold financial reserves sufficient to permit the running of all Board activities for two years. All excess funds are then returned to the National Office for investment on behalf of all GSA members throughout the nation. Our own Manawatu Branch fully complies with this policy, rendered especially urgent by an aging GSA membership which will necessitate more and more Branch responsibilities being taken over by National Office.

Finally, as Christmas and hopefully better spring weather rapidly approach, I wish you all well for the future during the remainder of this year, and the first half of 2025.

Finance

As Roger has mentioned we have restructured our finances to comply with the Financial Reserves Policy approved in August this year. We now have Term Deposits (reserves) of the required amount of \$13,500, being the equivalent of 2 years of our disbursements from subscriptions, and together with a balance in our operating account at 30 September of \$5,469, our finances are in a sound position. We have returned \$10,000 excess funds to National office and in future will review our financial position each year in March to determine if we have any further excess funds to be returned.

End of Year Function

Given the many positive comments from last years function we have again organised a Christmas Social Luncheon at the Verdict Cafe, 32 The Square, Palmerston North, on **Tuesday 26th November 2024**. With the continuing rises in the cost of living the cost of the meal will increase to \$60 per person. In accordance with GSA policy, the Branch Committee will subsidise the cost by 50% and, consequently, the cost to individual members is only **\$30.00** each.

Parking is available in the Square about 50 metres from the Verdict and Supergold card holders who are ratepayers can obtain a parking permit from PNCC which provides free parking from 9:00 AM to 3:00 PM Monday to Friday.
