#### **COMMITTEE MEMBERS**

Although the bulk of our committee has remained the same, we have been pleased to welcome David Cumming into the mix. I am sure that as he gets to know us better, he will be an active member of your committee.

#### CHRISTMAS LUNCHEON

Again, we had a most memorable lunch at The Conservatory within the Hamilton Workingman's Club. Because of other functions, parking was an issue. We will attempt to avoid clashes in the future.

### **COUNCIL MEETING (GSA NATIONAL ANNUAL CONFERENCE)**

Held in early September, Council was well attended by all branches. Discussions included minor changes to the constitution: the removal of the word "Welfare" (The GSA is not a welfare organization) and an amendment to quorum numbers in order to make it easier for smaller branches to hold an AGM. Ireen Muir (Annuitas) gave a very enlightening talk on the workings of that group. Annuitas Management is joint venture company owned by the GSF and the National Provident Fund (NPF). It serves the GSF Board and NPF trustees and manages policy issues and service agreements. Datacom administers the scheme. It employs 23 dedicated staff whose sole role is to work with GSF and NPF inquiries and payments. The GSF has \$5 Billion in investments; the NPF has a further \$2 Billion. Ireen emphasized the importance of members keeping Datacom up to date with any changes to relevant, personal details. She recommended that members provide Datacom with copies of legal documents, including power of attorney and any documentation that relates to a partner or spouse. She couldn't stress this enough. Further, she also reminded us that neither Datacom/GSFA nor the GSA will ask for a member's bank details.

### **REGIONAL MEETINGS**

We hold five a year in late September and early October: Cambridge, Matamata, Otorohanga, Taumarunui and Te Kuiti. Although attendance fluctuates, it is always great to report back to our 'out of town' members.

### MID YEAR MORNING TEA

We had a most interesting talk this year from Ross Hargood who chairs the Waikato Regional Theatre governance trust. He enlightened us on the workings of the new theatre being built Victoria St. Due to be completed later this year, it will be a great addition to the City. Ross also noted that the project is on budget.


### MEMBERSHIP
