Speaker: 11.00am Professor Peter Lineham, retired well-known Professor and commentator on Religious History. His topic is:

"Explaining the Phenomenon of Brian Tamaki and the Destiny Church".

He will look at it objectively and professionally. Peter's brief biographical background is: **Professor Peter Lineham** has for many years written and lectured extensively on the religious history of New Zealand, although his earliest work, continuing, was on the eighteenth- and nineteenth-century history of British Protestant sects. His recent work has focused on broader trends in contemporary religion, although he has not lost his fascination with the nineteenth-century adjustment of religion within New Zealand. His most recent book is **Destiny: the**



Life and Times of a Self-made Apostle (Penguin, 2013). He is currently engaged in various projects on new religious movements in New Zealand, and on Brethren, Protestant, Evangelical and Anglican history. (Like ourselves he is a recipient of GSF).

PONDERING ON LIFE AND WHAT'S AHEAD - Eric Bowater

We in the GSA older demographic are a diverse lot.

But hopefully every one of us has attended to the making of a legal Will (and a Memorandum of Wishes) as to where we want our assets to go after our death. This is a vital task, as is also the establishment of an EPA (Enduring Power of Attorney) for Welfare and Property if we become incapacitated while still alive and can't manage our own affairs.

I know of an older couple with declining health, owners of a multi-million- dollar farm, who stubbornly refuse, despite much urging, to establish Wills, which is setting up for very expensive High Court adjudication for their 4 sons.

Some of us GSA people have lived solo all our lives, and are well used to what that entails. Many of us are widows (since women tend to live longer), receiving the halfannuity along with NZ Super. Some are widowers, learning the fine arts of cooking for themselves (and maybe on a half-annuity as well). Some are divorcees. Some of us are still fortunate to be in a couple relationship, sharing household responsibilities. Some of us have one of a couple living independently while the other requires rather expensive rest home, hospital or dementia care.

Sadly, I have just recently joined the widower club.

Margaret, my dear wife of nearly 63 years, gradually developed coughing and breathing problems which her GP thought were asthma-related or heart-related. When admitted to North Shore Hospital in late October, these problems were diagnosed as caused by accumulation of pleural fluid, which in turn was caused by inward migration of cancer cells from an undetected breast tumour. After pleural drainage and stabilization (with no feasible oncology treatment possible), she was moved to Te Mana Private Hospital for her final week of very good palliative care.

She was quite philosophical over the prospect of dying at 86, which happened on November 26. On December 2 family, friends and colleagues gave her a splendid celebration of her life and farewell, and we've set up a memorial scholarship in her honour in an area she was passionate about.

Fortunately, we had earlier, together, done much practical and financial planning, and a lot of reading and spiritual reflection over end-of-life matters, whichever one of us died first (being male and a year older, I thought it would probably be me!).

So I use this experience with my Margaret to urge people in a couple relationship, to do this practical and spiritual forward planning, so that whoever is destined to go first can know that the survivor is well-equipped to deal with what follows.

And those who are already living solo: do the same for your descendant family and your friends: they will thank you for it. You might even sit down to write your memoirs—your life story and your reflections on it—as a legacy (as Margaret and I each have done).

Which brings me to our own Super News publications and catering costs which unfortunately have not escaped the ravages of inflation and you have guessed it - our increasing costs must now also be addressed.

However, it is also important to note that additional funding has been kindly provided during 2023 and now also promised during 2024 from the main GSA Auckland Branch for which we are most grateful.

Accordingly, I just want to flag that your committee will need to tentatively discuss this aspect with you at our next meeting to sound out opinion - but we may not by then have firmed up concrete proposals to put to you for consideration.

In that case it may simply mean that if no firm funding consensus is reached on 22 March - that then having taken on board your views we would plan to come back to you at the AGM later this year with considered final proposals.
