## **CHAIRMANS REPORT:**

It seemed only a short time ago that I penned a Chairs Report referencing the upcoming general elections. Since that time, we have had the elections, navigated the highs and lows of Christmas and are preparing to celebrate Easter in a way we believe appropriate. But what hasn't changed in that time is our need to continue to mitigate the inevitable loss of membership and to ensure our Branch can remain viable as per the predications made. Since the last report our membership has decreased by 73 to 1402. Even the attractiveness of retiring in the Bay of Plenty didn't encourage any members to transfer in from other regions. Mercifully none transferred out either.

Jeannie has recognised this again and made a huge effort to visit outlying areas and not let distance from Tauranga hinder inclusiveness for outlying members. In November she organised the meetings and visited members in Thames, Whitianga, Whangamata, Waihi, and Whakatane. Her commitment to the Secretarial role has been recognised by our Liaison Officer and has sparked discussion at Council on roles, responsibilities and remuneration for Secretarial duties. This will remain a work in progress for this year with incremental changes hopefully making the current role more attractive.

In the February Committee meeting a resolution was put forward requesting the Board to consider the benefits for all Branch Secretaries to meet bi annually. This will enable National Office to develop

consistency over the national Branch secretaries and streamline the practises contained in the operations manual. The benefits for secretaries are to encourage National Office to develop consistency over the National Branch Secretaries. We await the outcome with interest.
