# Chairperson's Report.

By the time you read this newsletter, it will be nearing the time of this year's budget. I write this piece with two months to go and with only a crystal-ball to gaze into, fractured and discoloured though it is becoming.

With most of our members having been in some public service there has been lively talk about politics as Ministry grants will be cut. During election campaigning there was a lot of talk about wasted money in the public service although very little of that talk gave me *evidence* to see just what was being referred-to. In my career field, teaching, I seemed to have been surrounded by a shortage of resources to do a really good job, so months of mantra about wastage did not make sense to me. A responsible government should be putting *more* into education. I suspect that many of you as ex-employees from other Ministries would be saying the same thing. The truth is out, of course, because the Government has told us just how much waste there is: 6.5% or 7.5% and chief-executives are scurrying around to find their "waste". It is very interesting that all Ministries are deemed to be wasting nearly the same amounts, within 1% of each other. I wonder how the Government knows that? I wonder what current public servants feel about being thought of as wasters, or even that their whole job is now being considered to have no value? I wonder too, whether the reduced public service will be reimbursed for inflation cost from the last year. If not, public service cuts could approach 12%. It has now been suggested that not all Ministries will supply the Government with excess cash but rather, like health, any "wastage' will just be redistributed to front-line services within that Ministry. This guarantees that some Ministries will lose much more than 6.5 or 7.5%.

Never mind, it will only be the "back-office" which will be affected! That term "back-office" was invented some years ago, again during another political campaign and probably some public-relations specialist got good \$\$ for what is now an old and rather nasty slogan. It has been left to chief-executives to sort out who their Ministry calls "back-office" and to protect their "front-line" services. Would a technician be "front" or "back"? How could a hospital doctor help people without the whole staff working together? Come to think of it, is a chief-executive "front" or "back"? Enough of my grizzling and on with some local news of our Association.

Canterbury/Westland is like other branches, with membership reducing by, perhaps, 6% a year. Discussion will continue about how our Association manages branches which get too small and cannot regularly get volunteers for their committees, particularly chairpersons and secretaries. Our branch remains lucky with a stable committee and with an injection of energy from Tony Gooding, a recent retiree. Part of our stability is because Janine, our secretary, who has been with us since 2003, and since 2012 she has taken on additional work, such as the membership/ database and the secretary/treasurer of the Walker Trust. Our annual meeting is on Tuesday, May 28<sup>th</sup>, 1.30pm, Papanui RSA. We would like to see a good attendance because, although members haven't been clamouring to attend our AGM's, two years ago we couldn't even attract a quorum of 20 from our more-than 2000 members. That was embarrassing as the National President waited patiently after coming to our meeting from Whangarei. This year, our President Alan Straker has other commitments and cannot be with us but another Board member, Anne Gover, is willing to attend. Anne lives in Invercargill, is a constructive member of the Board and as well as informing us about Board matters, you will find her interesting to talk with. I remember annual meetings of clubs many years ago when it was almost traditional that members avoided the Annual General Meetings in fear of being requisitioned onto the committee. I can assure you that does not happen at our AGM although volunteers to be nominated are always welcome.

A very early shout-out for our Christmas luncheon. Last year we went back to the Richmond Club, London Street, off Stanmore Road. It is a new building after earthquake-damage required a replacement. Very pleasant conditions and good car-parking were highlights. Although you will get usual details in your November newsletter, you could turn the pages of your calendar and enter the date now: Tuesday, December 3rd, midday for the start of the meal. On a cold, rainy day last year I was impressed with the warmth of service and convenience of the venue.

I must at this time thank all the visitors for the job well done.


Special thanks are extended to Margaret Keen, who keeps us supplied of the beautiful cards, that she makes.


