PRESENTATION FROM THE CHAIR OF THE RETIREMENT VILLAGES RESIDENTS' ASSOCIATION

The guest speaker at our September branch meeting was Nancy Nielsen, who chairs the Auckland Central branch of the Retirement Villages Residents Association of New. The RVR is a fast-growing national association, formed to promote and protect the rights of retirement village residents in New Zealand. It is focused on providing a voice for residents in retirement villages on issues related to the Retirement Villages Act 2003 and the Retirement Villages Code of Practice 2008. The Act defines the rights of retirement village residents when they commit to an Occupation Right Agreement (ORA) with the owner of a retirement village to purchase a license to occupy a villa, cottage, or apartment. The RVR should not be confused with the Retirement Villages Association, which represents the interests of retirement village owners.

In her talk, Nancy described a number of anomalies and injustices which the RVR is working to ensure are addressed as part of a forthcoming review of the Act. This has involved the RVR working with other organisations such as Grey Power and with the New Zealand Government. It is encouraging that there appears to be widespread agreement across the main political parties of the need for change.

Membership of the RVR is open to all retirement village residents, with associate membership available for family and friends. See www.rvrnz.org.nz for further information.
