Committee Member Profile:

Ken Crosswell

- I Joined the Post Office as a telegram boy in Wairoa 1946, progressing through the Postal, Telephone Exchange, learning morse later transferred to the Trentham morse school, where I qualified in morse and Teleprinter telegraphy, then transferred to the Wellington Telegraph Office.
- After three months I was transferred to Auckland, Wellington, Cambridge, New Plymouth, Hamilton and finally back to the Auckland Telegraph Office in 1953, where I spent four years in the Telegraph Office. While living in Auckland I met Maureen, later becoming engaged and married in August 1957. In September I was transferred to the Auckland Cable Station (Cable & Wireless Ltd) Oversea cable telegraphy. I returned to the Auckland Telegraph, April 1962 and in July that year I was promoted as Manager, Telegraph Branch Hokitika. Our eldest daughter arrived two weeks after arriving in Hokitika, we enjoyed this time as a family and our third son arrived early New Year's Day 1964. My position as Manager was being appointed Excise Officer, Customs Department, which involved visiting the 2 Local breweries where we checked Specific gravities of the brewing contents and provided with samples of the local brew. In 1969 I was promoted to Technical Supervisor, Wellington Cable & Wireless Station remaining there until late 1977, during this period our youngest daughter arrived completing the family. I was appointed Manage, Cheque Encoding Centre, Lower Hutt, where the staff processed all Post Office cheques, Payroll, Radio & Tv Licencing and Stores. My final promotion was to the Napier Telegraph Branch as Manager and I Retired in June 1984.
- Retiring at 54 years of age led me to other ventures in the racing industry, where I installed TAB betting machines, maintaining, and replacing faulty machines, I travelled to race meetings from Wairoa, Hastings Woodville Feilding Levin and Masterton for 6 years. Maureen set up a Public Typists business associated with an accountant, the latter setting me up in the accounting.

I covered audits for the Napier Cosi Club such as checking stock, wages and installing the TAB for their club members. The Public Typists business was prospering, so we converted over to the early computers, with knowledge of these I could assist both Maureen and the accountant.

- One day a search agency from Auckland called into the office and this led going to the Land & Deeds office searching titles both for Real estate and Companies, this was very lucrative. In 1989 we sold the business and set out on a caravan Journey from Napier via Gisborne to Tauranga, where we decided to purchase a house and settle down, which our desire 30 years earlier.
- We settled in Welcome Bay, later moving to the Mount for seven years, then back to Greenwood Park village in Welcome Bay 200., In 2006 our friend Dave Webster (GSA BOP committee] invited me to a committee meeting, where I have been ever since, enjoying meeting member as treasurer. Maureen took over the Secretaries position for several years until just before her death 2013, when I covered the Secretaries position for a temporary period. I really enjoyed working with Arthur Johansson as we both had. a great relationship from our Post Office days. Over the time of being treasurer, I enjoyed working with all committee members.
