Chairperson's Report.

About a month ago I was chatting to a friend who is living in USA. We have known each other since school-days in Christchurch but in his early fifties he lost his wife to cancer and he decided to take his scientific research back to some of the places where he had really enjoyed working in the past. One of those places was Madison, Wisconsin, USA. He is still in Madison, because ...yes ...you guessed it, he met a lady. Although retaining his basic Kiwi values he has often said that the USA is a very interesting place to live but his comments over the administration of Covid-19 have been very negative. (His word was "diabolical".) Hardly a surprise, but to us in New Zealand we could easily lose sight of just how good the NZ response has been, both through Government control and through the work of medical services. There is always the thinking that we shouldn't look back, we should be 'progressive' and look to the future. With Covid-19 mortality though, every person not killed by it is a person who still has a future. I thought I would share some figures with you.

Any comparison involving Covid-19 mortality is an inexact science and depends on when the omicron variant peaked, how a country defines Covid 'deaths', the socio-economics of the population and other variables. My only correction is for population, and for ease of calculation I am using a NZ population of 5 million. I am using the assumption that the NZ deaths will be 400 by the 6th April.

In my friend's state in the USA, Wisconsin has a population of 5.9 million and has had 14317 deaths by the 4th April. When corrected to NZ's population of 5 million, that means for every one in NZ dying of Covid-19, around 30 have died in Wisconsin. For the whole of USA, the figure is 36, and for New York state, it is close to 42 dead for every one Covid-19 death in NZ. England's figure is 32. For Australia the figure is just above 3, mostly from New South Wales and Victoria but we shouldn't forget the amazing figure for Western Australia which is only one death of theirs for every 4 of ours.

What is the point of these statistics in a GSA newsletter? Well, compared with the situation in, say, Wisconsin, for each who died in New Zealand there are 29 other people in New Zealand who didn't die from Covid-19. Just who are they? *They are us. Most are over 65, superannuitants, who still have a future!* I have heard it said that if they hadn't died of Covid-19 they would have died of influenza. There is maybe some validity for that statement in New Zealand but it is not true for the USA where deaths from Covid-19 have been nearly 10 times the number who would have died there from influenza over that same period.

Back to local things. Being unable to hold the annual Council meeting for 2021 hasn't stopped GSA continuing to look to the future. A recent proposal to the Board suggests a need to look at payment for Branch secretarial services and to have a formula to calculate reward for those doing secretarial work. This will affect our Branch because some years ago we decided to pay our secretary-treasurer, and apart from the other larger Branches Auckland and Wellington, most branches have no formal reward for that work showing on their accounts. Formulating a standard, fair way to reward secretaries will be quite a complex process and one which must be open with plenty of opportunity for consultation. The Canterbury/Westland Branch system has resulted in Janine not only being the most experienced of all Branch secretaries but also the longest-serving person in that position.

Our Branch committee members continue to provide a stimulating, interactive environment for discussion and I am most grateful for all their work through the year. I am very much aware though that GSA needs a flow of younger members into committees and that is certainly the case for our Branch. A message to members within the first few years of retirement: please think about whether you can bring some of your energy and innovation to help GSA remain a viable guardian of your superannuation scheme.




ARE YOU LIVING IN A DE FACTO RELATIONSHIP? In New Zealand a de facto relationship, *if you have lived together for at least*

three years, has the same status as a married couple.

At the time of your annuitant partner's death Datacom will require evidence of your relationship. Therefore, it is important that you have the following:

- 1 Joint bank account
- 2 Rates account in both names
- 3 Power/telephone account in both names
- 4 A legal document stating when your relationship commenced

Ensure you have the above now, don't leave it until 'tomorrow'
