All members are most welcome to attend. You are also most welcome to bring friends.

Historically, only about 50% of Government Superannuitants are members of our Association. People who have been strong supporters of Public Service groups during their working life seem to consciously or unconsciously disconnect from support when they retire. There will always be a need to fight for individual and collective rights. While there is a Government, there will be cost cutting drives. You need to be assured that there is a group ready and able to support you or your surviving spouse. In return we need individual members to support their Association by joining.

Applications can be made on-line at gsa.org.nz, or ask our branch secretary (0800 888 472) to send an application form to a prospective member. The GSA subscription is only \$1.65 per four-weekly annuity payment. A couple sharing an annuity pays one subscription.

Chairperson's Report

Nearly another 6 months has passed since the last newsletter and I continue to be propped up by an incredible team, making my job relatively uncomplicated. Janine, as Secretary/Treasurer has been immensely helpful. In addition, she has a wealth of knowledge and experience including regular contact with Datacom and Secretaries of other Branches so she keeps us informed with news of the Association through different eyes. If you have any need of information, Janine is the person most likely to know an answer, or who can put you onto a likely source of help. The Committee of Dick Kitto, Gavin Stuart, Bernie Rose, Dugald McDonald, Ron Creighton and Gavin James have kept me on my toes throughout meetings with unflagging vital debate on all aspects of GSA functioning, always seeking further knowledge and always looking for solutions. Dick Kitto deserves great commendation for his role in organising the February Committee meeting in Greymouth. He thought of nearly every possible exigency in advance, and contacted numerous groups and institutions in Westland to ensure the meeting was publicised. The one major snag, causing a late change of venue, could not have been foreseen but Dick took it all in his stride and made sure the meeting would take place with the minimum of disruption.

Council 2015 passed a resolution to take another look at the tax issue. This could be the last time GSA will visit this matter because it was only a last-gasp motion from Auckland which kept the matter alive and a group will now look at probabilities of making any further progress. This will be done by reading all past documentation available to the Association and anything new, evaluating whether we can make a viable case under the current political climate or predictable future ones, and if so, present strategies for that future. You will be aware that at the time of your retirement, your future annuity was calculated using several factors and one of those was a multiplication by 0.7 for Government Super Fund people and by 0.6 for National Provident Fund people. This reduction of 0.3 or 0.4 is a factor which is in lieu of tax. That is, in this time when most of us are paying 17.5% tax on our other income, on our GSF or NPF annuity income, we are paying 30% and 40% tax respectively. While many GSA members think it is a problem which could be too hard or too likely to spur Governments to nastier solutions, Canterbury/Westland Branch has always maintained we must continue to fight this inequity. It is therefore appropriate that I have been invited to be part of the investigating group. I will not be a delegate, so I won't be bearing a Canterbury/Westland banner but I am confident the group will come up with the best answers. Members of the group are very experienced, are rigorous, willing to do their homework and will strongly argue points of view. The others are: Convenor Mark Leys, Auckland Chairperson, Board member; Tony Hamilton, Northland Chairperson, Board member; Elizabeth Smaal, Wellington Chairperson; Alec Waugh, Auckland Deputy Chairperson; Peter Harris and Mark Byers who are from outside GSA but have expertise in this field. Much of our work will have been completed by the time of our annual meeting so I may be able to give some indications about progress.

Our Board liaison person, Diane Ward, (Nelson) will be attending our annual meeting and will be able to bring us up-to-date on Board matters and on any other thoughts she wishes to share.

You may remember that in the November 2014 Super News had comment on an action that Mr Ernest Findlay Heads had taken against ACC. The Human Rights Review Tribunal was considering Mr Heads' rights under the Human Rights Act.

In brief, when Mr Heads' wife died in a work related accident, he became entitled to an ACC payment, a set percentage of his wife's average income. This is normally paid for a five year period to give a person time to adjust personal finances. However, at the end of one year, Mr Heads had to choose either his NZ Superannuation, or his ACC payment. He was told that he could elect to have one – He could not have both. Why? Because the law says so!

Mr Heads took an, "Over my dead body." attitude. "I am entitled to both." He won.

The final total was \$16,161.68, and this was administered by the Public Trust. It is believed that the reason for this bequest, was that the only visitors that he had over his last few years, were GSA members.

On 1 April 1993 it was agreed that in keeping with the spirit of the Walker Trust, our members aged over eighty would be visited on or around their birthday by a voluntary worker, and given a small gift. The cost of this is reimbursed by the trust. Our convener, Bernie Rose co-ordinates these visits and also sends out birthday cards to all other members over 80, if their birth dates are known.

Bernie would be delighted to have a few more members to actually do a home visit or two, particularly in the Riccarton, Burnside, Bishopdale, Ashburton, and Hokitika areas. If you want to consider volunteering, please ring Bernie and have a chat to him about it. (03 313 1569)

Please note that members need to advise our Secretary of their birthdate if they wish to have their birthday acknowledged. We have no other record of a member's age or birthday.

In 2000, following some dissatisfaction with the Public Trust, the fund was transferred to the Branch to administer. An Advisory Panel was set up for this purpose, and this panel consists of our Chairperson, our Secretary/Treasurer, and our Walker Trust convener. A statement of account appears every year as a part of our Annual Accounts.

The Trust currently has \$14.000 invested, and around \$3000 in a working account. With interest and the profit from the Christmas luncheon raffles, we manage to maintain the funding for the Trust.

Is your GSA Board working for you?

It certainly is. Current priority projects include-

- 1. Mark Leys leading a "Tax Equity Working Party", reviewing what has been done over the past few years on this issue, and developing strategies that might have more success in 2017.
- 2. Bill Robertson is working with an actuarial expert to examine and question the information provided to cabinet prior to the 2009 COLA adjustment for pre 1985 annuitants.
- 3. The board has engaged a QC to support a member in an appeal against a GSFA ruling on the question of what constitutes superable remuneration. Any success with this case will obviously carry over to other annuitants with the same issue.

No doubt there will be more to report on these actions at Council, and in the November newsletter.

A Meeting on the West Coast.

We have a policy of regularly taking meetings to centres other than Christchurch.

Geographically we are a very large branch. We want all members to have the chance to be involved in our meetings, but we fully understand the difficulties created by distance. If members can not get to meetings, we will take meetings to the members. In 2014 we took a meeting to Ashburton. In 2015 we took a meeting to Rangiora. This year, we took the February meeting to Greymouth.

We advertised the meeting as widely as possible, and received 63 replies from members, indicating that they would be attending the meeting at the Greymouth RSA on Tuesday February 23. We spread the advertising to groups that might contain non-members to ensure that all GSF annuitants felt welcome to attend.

We struck major problems the weekend before the meeting. The wife of the patron of the RSA passed away, and as the funeral was being held on February 23, all planned activity at the RSA was cancelled to make the facility available for family and friends after the funeral. We understood this.

We transferred the venue and the catering to the Marist Rugby League Club, and started to get the word out to Coasters that the venue had changed. Within hours our secretary had picked up that there were members who would not be able to attend, as there was no wheelchair access to the Marist Hall.

Another venue change – this time to the Union Hotel. Beat the drums again. Different tune.

During this process, I spoke with a number of people on the coast, and without exception, I had nothing but cooperation and friendly support from everybody involved. There was no negativity about the situation. Everybody worked very hard to ensure that everybody was supported. Tremendous. Well done Coasters. The prize for cooperation would have to go to Merve Scott from Greymouth Taxis.

We put a couple of our members up at the RSA at 1.00 to re-direct members to the Union Hotel. To cater for transport difficulties met by people who arranged to go to the RSA, we needed a Taxi Van to be available at the RSA from 1.00 to after 1.30 to ferry people to the Union Hotel. This was arranged, and Merve was there promptly at 1.00. There were a quite a few people who turned up at the RSA, and most drove themselves to the Union Hotel. Just after 1.30, Merve took a group down to the hotel, and insisted that he did not want payment for the time that he gave us. A big, "Thank you Merve".

We realise that a number of people were probably inconvenienced in ways that we don't even know about, and we hope you will forgive us for this. 47 West Coasters turned up for the meeting. Well done indeed considering we have under 140 members on the Coast. We had groups of members from Greymouth, Hokitika, Westport, and Reefton in attendance.
