## Report from the Chair, March 2022.

Since my last report, we in the Region have been experiencing yet another Covid outbreak, this time of the highly infectious Omicron variant. I would like to remind members to keep safe during this trying time, but also to reassure you all that there will be better times ahead. Because of the current situation, the annual meeting of the GSA Council, originally postponed in September 2021 and rescheduled for 30 January 2022, did not take place, important business being dealt with on-line.

I can report that your local branch committee is in good health, with members continuing to meet regularly and discuss issues relevant for both our branch and nationally. However, overall membership of GSA is inevitably declining due to old age. Last year the GSA recorded a net loss of 1,651 members. In this context it is vitally important that at the branch level we continue to attract new committee members if we wish to retain the Manawatu Branch as a viable entity in the future. The alternative, should we not be able to do this, would be amalgamation with a neighbouring branch and the possible loss of local input. I want to stress that committee membership is not onerous and provides a golden opportunity to make new friends and have some fun along the way.

In April you would have received the annual Cost of Living Allowance adjustment to your Annuity following confirmation of the 31 December 2021 increase in the Consumer Price index of 5.95%. I am sure that such an increase was most welcome to members, especially those who retired many years ago on smaller annuities. It is important to remember that over the years since the organisation's foundation in 1920, the Association has indefatigably fought for an annual Cost of Living Allowance adjustment, with the full 100% indexation for most members finally being achieved following the passage of the GSF Amendment Act, 2009. The Association is still campaigning vigorously, however, for the 100% Cost of Living Allowance to be applied to those who retired prior to 1985.

The Datacom document referred to above also includes some very useful information, especially for those who have changed their address or are contemplating changing their address in the future. We are also reminded that, because Identity and Survival forms are no longer sent to New Zealand residents, it is extremely important that Datacom is notified immediately following the death of an annuitant. The GSA has produced a useful booklet for Members called "Personal data for....". Copies of this booklet will be available at the AGM or can be obtained through the Branch Secretary."

On an altogether brighter note, I would like on behalf of the Manawatu Branch of GSA, to extend to you all a warm invitation to attend our AGM to be held at the Verdict café and Restaurant on 1 June 2022.

Once again, please take care and stay safe!

**Membership** as noted by the Chair our numbers are declining, however, I have noted that some of our reductions are due to members leaving our Branch and moving to another. Nevertheless, there has been a steady number of members dying, requiring bereavement letters and advice being sent to surviving spouses. I must sadly advise of the death of two of our Branch's Life Members:

**Arthur Evans** who passed away on 29 October 21 (Arthur was also a staunch member of the Ashhurst RSA); and

Dorothy Fordyce who passed away on 5 March 22.
