The Government Superannuitants Association (GSA), has as one of its goals 'to actively pursue the recruitment of new members'. You will not be surprised to hear that the number of government superannuitants is in continual decline as the scheme was closed to new members early in the 1990's. As the years go by, there will be fewer and fewer annuitants. Inevitably the Government Superannuation Fund will need to be wound up in the future and as annuitant numbers decline the services of the GSA will assume increasing importance. The role of the GSA is to provide support, information and advocacy services for members and take action to protect the interests and welfare of members. One important service the GSA provides is to enable the spouse/partner of members to join the association as a 'Spouse/Annuity Partner' at no additional cost. Those who have done so

have seen the need, particularly if the annuitant dies first, as this can ensure a smooth transfer of entitlement to half the annuity.

Government agencies are reluctant to back date entitlements and GSA can assist at what can be a stressful time.

To remain effective the Association needs to maintain its membership strength and accordingly recruitment programs to contact potential members and encourage them to join. It is difficult with the privacy act, to obtain lists of those retired members who do not belong to the GSA.

There-fore the best way to contact those members would be from existing members to approach their friends and colleagues who could invite them to join the Association.
