Nick's Report on GSA Council Annual Meeting 2018

The Annual Meeting was held at the West Plaza Hotel on 2nd and 3rd September 2018. This central Wellington location was a good venue with good meeting rooms, restaurant and accommodation all within good access.

Janice Campbell our outgoing President welcomed Branch representatives to the Annual Meeting and presented her Report to the meeting. The Executive Officer Jenny Barclay has resigned before the Council Annual Meeting and her place was taken by Acting Executive Officer Alan Peck. We worked through the Agenda with the following being the main points:

Communications: Clear communication is a key function of the Association but the costs of Annuity News and Branch Bulletins are steadily increasing, since 2014 there has been a 300% increase in costs. * To reduce the costs the Board are looking at reducing the Annuity News page numbers and the quality of the paper and it may be time for members to receive their Branch circulars by email. The Association's Website was also questioned and could perhaps be updated to explain what our objectives are. *The Board remained committed to quality communication to Members and prospective Members.

Organisation: The main objective of the GSA is quality service to members. * Branches are in good shape. The annual meeting of one vote per 500 branch members remains. * Recruiting for a new Executive Officer is well in hand. * Board Meetings could be cut from 4 weekly to 6 weekly with Skype being used more frequently. * Attendance of Board Members at Branch Meetings was questioned.

Member Services: Holding our membership numbers and recruiting new members is a high priority.* The current State Services Commissioner is very helpful to the GSA by allowing the State Services communications system to contact pre-annuants in a positive way.* Over the last 12 months we have had a loss of about 1000 members. This coupled with the enrolment of new members and spouses showed that GSA had an over-all loss of only 172 members. There is a great need to work on enrolling as many pre-annuants as we can. Lapsed members are also an area of concern and Branches will be asked to make contact with lapsed members in their Branches and encourage them to rejoin.

Financial: The accounts were late due to illness and almost all Branches had a surplus. Concern was expressed at the projected 2018-19 deficit of \$18k. * Centralisation of financial reserves: The 2017 decision was reversed and the Board have 12 months to come up with a better plan. Disappointment was expressed at the poor information and organisation from the Board on this matter over the last 12 months with that no clear plan on how the Centralisation would work especially on how the money would be invested and safe-guarded.* The possible change of the split of the subs between National office and Branches was discussed with no decision made here.

Election of Board: Our new president is Tony Hamilton (Northland) this meant that Bryan Whisker retires and all Board nominees were elected except Rob Brangwin (Hawkes Bay) Nick Farr – Delegate
