Government Superannuitants Association, Taranaki Branch: Chairman's Report: April 2023

Once more Autumn has arrived, and it is time to think about our AGM.

Last week I received my annual Cost of Living adjustment notice from Datacom, so likewise, you should all know what your annuity is for the next 12 months. We have to remain grateful that it was through foresight and negotiation by some of our former members that the current situation exists. While it may not reflect the true cost increases that we face, it does substantially buffer us from facing a steady reduction in our living standard, as those who preceded us did, and to an extent, those who still live with the failure of the Government to fully implement the 100% adjustment for the pre-1985 retirees and their surviving spouses.

Alan Peck, our Board representative, will be attending our AGM on 16th May, and will update us on the relevant matters that the Board is dealing with. We had planned to hold our meeting on the Wednesday, and the Whanganui Branch, which Alan also represents, had booked their meeting on Thursday 18th May, before we confirmed our arrangements. We then had to fit in with existing bookings at the Plymouth Hotel. Although costs have risen, the Branch will meet the cost of the morning tea for the AGM and that way we keep your cost to the same \$25.00 each, as with previous meetings. However, we may need to review costs for the future, and this can be discussed in General Business at the AGM.

Our guest speaker for the AGM will be Andrew Clennett, CEO of Hiringa Positive Energy (or his deputy if Andrew has an overseas commitment), who are developers of the Taranaki Hydrogen project.

Before we get to the interesting parts, we do have to elect a committee for the coming year.

I have been one of the Branch delegates to each Council meeting since 2011 and have chaired the Branch for 9 years so far. While I don't intend to stand down at present, I took on the role as a caretaker Chairperson at the 2014 AGM. My best skills do not include innovation or administration. I am prepared to continue for another year, as are two of the current Committee members who took on their role to preserve the viability of the Branch. However, if no one steps up to take these positions (minimum of 5 members), then the Branch is no longer viable, and the Board will decide whether there will be amalgamation with another Branch, or some other form of management. To avoid the loss of Branch independence, we need fresh volunteers for the Committee.
