Government Superannuitants Association, Taranaki Branch: Chairman's Report: April 2022

Another six months have become history and we now get shortening days and the prospect of winter in a couple of months. For some it can be a problem with less light, and not being able to get outdoors as much as we might wish. However, it is still warm, and hopefully you are grateful for that.

At our Christmas meeting we were well entertained by our guest speaker Leslie Dowding whose speciality is storytelling, which she is particularly adept at. While much of her work has been with children, she has a repertoire to suit any age group.

At the National level, there have been two attempts to hold Council meetings, firstly a re-scheduling of the annual meeting to Labour Weekend, and later, to hold a Special meeting at the end of January. Both were cancelled due to restrictions around Government conditions due to the Covid situation.

Another casualty of the times is that there has been no sign that the Government has taken the action necessary to achieve the 100% Cost of Living Adjustment (COLA) for the pre 1985 retirees. On 7th March we received a paper from Tony Hamilton detailing the current situation where the finance minister has advised that it remains under consideration but will not necessarily be included in this year's budget.

It was pleasing to receive notice of the indexation adjustment of 5.95% of our annuity for the remainder of us as it is obvious that most of us are living with significantly increased living costs.

Our National President Tony Hamilton is attending our AGM on 18th May to update us on what is happening at the National level. As well as attending the meeting he will be with us for lunch, and it will be a great opportunity to discuss any issues you have.

Alex Fahey has indicated that he will not be standing for the Committee this year. Alex has given over a long period of his life in serving the Railways Superannuitants Association, and latterly our Association. He has been on our Branch Committee since they merged with the GSA. Alex is a Life Member of our Association.

This leaves the current committee at the minimum Constitutional requirement of five members, some of whom have continued for several years now to ensure the viability of the Branch.

I have been the senior delegate to Council for ten years. We are now in the situation of barely having a viable Branch, and there is a need for some of the younger members (relatively speaking, but there are some) to step into these roles, and, for someone to understudy my role. I started knowing that I don't have a significant background as an administrator, and nor am I an innovator with the ability to generate new initiatives to advance the objectives of the Association. I only ever saw myself as a caretaker (I did advise members of this), and although I now have a much better overall picture and knowledge of the Association, there must be those who can become the next generation running this Branch. I don't believe that people should be pressured into involvement. The alternative is to volunteer, and it must happen if you believe in maintaining the viability of this Branch. If it doesn't happen, the fate of the Branch will have to be decided by the Board. I don't believe that Taranaki members will be as well served by any other arrangement that may be decided on.

To ensure that we will not be crowded, the committee has arranged for the hire of one of the larger meeting rooms at the Plymouth Hotel for our AGM on 18th May, and to try and ensure that we have a quorum to conduct the mandatory business, I have set up a Zoom meeting to commence at 1030 am. The meeting ID is: 863 642 6531, and the pass code is ZwnX3D.

If the business isn't completed within the 40 minutes allowed, then you will need to log in again using the same details (to restart the meeting will also take me a few minutes). If you have a computer and are unable to attend the meeting in person, or consider that the risk is too high, then this does provide another option for you.

While we again face increased costs at the Plymouth Hotel, the Branch is funding the room hire and the morning tea, so the cost to members is approximately half of the lunch cost. Because of the costs involved and the imperative to have a quorum (minimum 20 members), we would appreciate replies to Denyse as soon as possible indicating whether you will be attending in person, or via Zoom.

If there are other ways that you can see to deliver benefits back to the membership, the committee are always willing to consider new ideas.

I look forward to meeting as many of you as possible at the AGM.
