A question was asked about Datacom and the annual adjustment based on the CPI and how this was calculated. Alan Peck replied that details of how it is adjusted was published in the Annuity News April 2017 on page 3.

#### Annual Report

The annual report had been distributed in the April Branch Newsletter. Although the branch membership had reduced by 66, a total number of Wellington Branch members of 5,375 is encouraging. Recruiting is always an issue. The Board set up a working group to address this. The Council in 2017 decided to increase the cost of membership to \$2 each annuity payment or \$26 per annum. It is also proposed that financial reserves be centralise to strengthen the Board's ability to support branches that are likely to experience financial stress in future. This matter will be debated further at Council in 2018. Secretaries are following up on lapsed members. The Board's priority for 2018 is the petition to be presented to Parliament regarding the 100% CPI adjustment for pre 1985 retirees. In an endeavour to recruit pre

annuitants, contact is being sought with the Boards and Heads of Government Departments. An Australian member suggested that we also contact the Police Association.

It was moved and seconded that the annual report as printed be adopted.

The surplus funds are to be kept separate from the main Wellington accounts and are to be used for travel to social events. Graham Ellett was thanked for his work in managing the financials to wind up SuperTravels.

#### **Anvil House**

A member asked about the safety of Anvil House, the building the staff worked in, and how secure the computer system was in case of building disruption. Christabel Gibson gave a vote of thanks to Ian for his chairing of the AGM.
